RE: FREEDOM OF INFORMATION REQUEST - FOI861- CON-029742

Avon and Somerset Police and Crime Commissioner's (PCC's) office have now completed the search for the information which you requested on the 9 April 2021.

INFORMATION PROVIDED

A response to your request for information is provided below, with answers in blue.

- 1. How long does your Independent Scrutiny of Police Powers Panel meet? Onsite meetings are 6.5 hours and remote meetings are 2.5 hours.
- I) What date (DD/MM/YYYY) was the panel first operational? 13/6/2017.
- II) How many of the people currently on the panel are from a Black, Asian or Minority Ethnic background? (could you also tell me the total number of people on the panel as of the currently date) 7 of 14.
- III) How many of the identified BAME panel members are black? 4.
- Are panel members made to review a sample of stop and search and related body-worn video footage in meetings?. This can be a simple Yes or No answer. Members are not made to do anything. - 3. What sort of mandatory training do panel members receive in order to perform their role?. Mandatory induction training is provided in relation to reviewing BWV footage, Stop Search policing practice and Taser deployment and use of force. In addition to this, non-mandatory training is offered including; ongoing panel meeting training topics and observational training, for example: Taser training for Police Officers and De-escalation training.
