#### RE: FREEDOM OF INFORMATION REQUEST - FOI878- CON-31110

Avon and Somerset Police and Crime Commissioner's (PCC's) office have now completed the search for the information which you requested on the 7th October 2021.

#### Your request:

As regards the Scrutiny of Police Powers Panel Review of the 14/01/2017 Taser Case, please provide the following:

 "The Panel's usual practice is to publish a summary of each case the members have reviewed with the officers' details anonymised. Unfortunately, because of the notoriety of this case, anonymisation cannot be achieved and, exceptionally therefore, the Panel cannot follow their normal practice of publishing their comments on the officers' actions."

I appreciate that it may have been considered appropriate that the Panel's comments were not published, but, in my view, the circumstances do not bring this within the exemptions in the Freedom of Information Act. Therefore, please may I request copies of the panel's comments on the officers' actions.

2. "The Panel reviewed the January 2017 case in November 2018. This led to a number of questions being raised with the ASC. The Panel were disappointed with the delayed and limited response from the ASC to these initial questions."

- (i) the questions,
- (ii) any correspondence with the panel in relation to them
- (iii) any answers provided to the panel.
- 3. "The Panel also submitted questions to ASC about the repeated misidentification of X and how Taser was used in this specific incident."
