Avon and Somerset Police and Crime Commissioner's (PCC's) office have now completed the search for the information which you requested. Your request was transferred to the PCC's office by Avon and Somerset Constabulary on the 2nd November 2022.

The information provided relates to when the payments have been made, not the date of the hearing.

Question 1: Between the 1st of January 2022 and 30th of June 2022

Please provide the following information:

How much has been paid by the force to LQCs between the above dates for payment for their role as an LQC at police misconduct hearings - the PCC's office was transferred the budget from Avon and Somerset Constabulary for the payment of LQCs at the start of the 2022 financial year. Since April 2022 a total of £5,432.43 has been paid to LQCs at police misconduct hearings.

How many LQCs are at the forces disposable as of the 28th of October 2022 - 8

What has been the largest payment made to an LQC during the above period - £3101.10

Question 2: How much has been paid by the force to Independent Panel Members between the above dates for payment for their role as Independent Panel Members at police misconduct hearings - the PCC's office has held the budget for the payment of IPMs since the start of the 2022 financial year. Since April 2022 a total of £810.28 has been paid to IPMs at police misconduct hearings.

How many Independent Panel Members are at the forces disposable as of the 28th of October 2022 - 5
