
2023/24 Precept Survey Analysis – Avon and Somerset Police and Crime Commissioner

Results - precept

The first question respondents were asked is: *PCC Mark Shelford intends to ask for the maximum, annual, precept increase of £15 for the average Band D household. This is equivalent to £1.25 a month. Taking this information into account, how much do you agree or disagree with this proposal?*




We received 3,760 survey responses.

The responses were finely balanced, with slightly fewer people agreeing with the increase than disagreeing with it.

There is less support from those not employed by the police.

After asking whether or not the proposed level of precept increase was supported, respondents were asked about the reasons for their response (options below). Respondents were allowed to select as many options as possible. The top three reasons were supportive of an increase. The top 'negative' reason was that people think the increase should be funded by central Government (29.5%).

45.7% of respondents agreed they had confidence in the police while 34.7% disagreed.

32.3% of respondents agreed they had confidence in the PCC while 32.1% disagreed.

Methodology

Opinions about next year's precept were collected in two different ways. Firstly, an online survey was hosted on the PCC website and promoted by the OPCC. This survey was open – for anybody to complete – from 20th December 2022 to 31st January 2023.

The second method was a postal survey, 15,000 were dispatched on 3rd January. Targeting of these surveys was based on two strata: local authority area and ethnicity of the population. Firstly, each of the five local authority areas were assigned a number of surveys directly proportional to their total population. Within each local authority area, the surveys were sent to the LSOAs which were most ethnically diverse. Where part of an LSOA was needed to reach the total, addresses were selected at random.

It should be noted the plan was to consult for a 12-week period but this was not possible due to the late announcement of the precept levels by Government, therefore it was only open for 6 weeks.
