RE: FREEDOM OF INFORMATION REQUEST – 482

Avon and Somerset Police and Crime Commissioner's (PCC's) office have now completed the search for the information which you requested.

Your request details are in blue with our response following each question.

Please provide the following information for your Domestic Abuse Perpetrator Programme for the 2022/2023 Financial Year

1. The Name/Title/Scope of the commissioned programme in your area

In 2022 / 23 Avon & Somerset OPCC held a contract with commissioned provider <u>Cranstoun</u> to deliver the <u>Drive Project</u> in South Gloucestershire. Case managers work with those causing harm in their relationships to prevent abusive behaviour and protect victim-survivors. Service users have been assessed as posing a high-risk, high-harm level of domestic abuse to the people that they are in intimate or family relationships with. They also often have multiple needs and are resistant to change. The Drive Project has an intensive case management approach that challenges service users to change and works with partner agencies – like the police and social services – to disrupt abuse.

I am aware that there are other Domestic Abuse Perpetrator Programmes available in Avon & Somerset but our office is not involved in these arrangements.
