RE: FREEDOM OF INFORMATION REQUEST - FOI 742

Avon and Somerset Police and Crime Commissioner's (PCC's) office have now completed the search for the information which you requested on 20th March 2024.

Your request:

I understand the Victims and Prisoners Bill will introduce a new statutory requirement on commissioners of victims' services, known as the 'duty to collaborate'. This will require Police and Crime Commissioners (PCCs), Integrated Care Boards (ICBs) and local authorities to work together when commissioning support services for victims of domestic abuse, sexual abuse and other serious violence.

Unfortunately in Bristol there are currently no female only abuse support services. Even the services which say online or in their charitable objectives they are 'by women for women' and/or for survivors dealing with the aftermath of domestic, sexual abuse and coercive control - have said there aren't any and they are in fact mixed sex. Female survivors of male abuse who need single sex services are currently left with no accessible support at all. Some have contacted 'female' abuse support organisations to ask for help on police advice and then found the service is mixed sex.

Please advise:

- 1- how the commissioner is collaborating with councils and ICB to develop single sex services for female victims of abuse currently excluded from help, before the Victim's Bill comes into force. If not, please advise.
- 2- what other plans the commissioner/ police have to fulfil their statutory duty to ensure there are accessible single sex services for female victims of male abuse. If none, please advise.
- 4- if the commissioner or police know of any single sex abuse services in your area for female abuse survivors (all the ones online we have checked are mixed sex), please advise
- 5- what action the commissioner and force will take to ensure police officers only refer female abuse survivors to female only services if this is what they request, or advise victims when no accessible abuse support is available locally.



Our response:

1. how the commissioner is collaborating with councils and ICB to develop single sex services for female victims of abuse currently excluded from help, before the Victim's Bill comes into force. If not, please advise.

Services Commissioned with funding received under the PCC's grant agreement with the Ministry of Justice do not have a specific or explicit condition nor do we have a statutory duty for the provision of single sex services. PCCs must have due regard for the specific need for victims in their local area and commission provision accordingly. As part of this, PCCs would be expected to follow guidance under the Equality Act 2010, whereby providers have the ability to restrict use of spaces on the basis of sex and gender resignment where this is justified.

As such, where we are recommissioning victim services at present, you will see we have undertaken an Equality Impact Assessment (see p.57 of our Commissioning Plan for narrative on the protected characteristic 'Sex' available on the OPCC website). You may wish to note that this includes the Avon and Somerset Independent Sexual Violence Advisor (ISVA) Service.

The specific services you are interested in are not clear from your request. However in order to assist we list below the possible services of relevance that the OPCC jointly commissions (with lead commissioners identified):

- Avon and Somerset Sexual Assault Referral Centre (SARC) with NHS England (lead) and Avon and Somerset Constabulary
- Avon and Somerset Specialist Sexual Violence Therapies with NHSE England (lead) , Bristol City Council, Bristol North Somerset and South Gloucestershire (BNSSG) Integrated Care Board and Somerset Integrated Care Board.
- Local specialist domestic abuse services receive some contributions from the OPCC into pooled budgets but are commissioned by Local Authorities (Bristol, Somerset, North Somerset, BANES and South Gloucestershire).

Details of services funded by the OPCC are on our website.

The OPCC eagerly anticipates more detail on the Victims and Prisoners Bill collaborative duty with ICBs and local authorities from government.

2. what other plans the commissioner/ police have to fulfil their statutory duty to ensure there are accessible single sex services for female victims of male abuse. If none, please advise.

As above, Services Commissioned with funding received under the PCC's grant agreement with the Ministry of Justice do not have a specific or explicit condition nor do we have a statutory duty for the provision of single sex services. PCCs must have due regard for the specific need for victims in their local area and commission provision accordingly. As part of this, PCCs would be expected to follow guidance under the Equality Act of 2010, whereby providers have the ability to restrict use of spaces on the basis of sex and gender resignment where this is justified.



3. If the commissioner or police know of any single sex abuse services in your area for female abuse survivors (all the ones online we have checked are mixed sex), please advise

The OPCC does not directly oversee, hold or maintain a list of single-sex services or referral criteria for services in the Avon and Somerset area. There are many independent organisations that provide support to victims of abuse, tailored to their specific needs.

4. What action the commissioner and force will take to ensure police officers only refer female abuse survivors to female only services if this is what they request, or advise victims when no accessible abuse support is available locally

To obtain information regarding the operational measures taken by Avon and Somerset Constabulary concerning the referral criteria for female victims, I recommend directing your inquiry to the Constabulary directly. They will be better equipped to provide you with accurate and comprehensive information on this matter.
